COR police chief would like feedback from the residents regarding their concerns about safety on the island. Maryanne Wiegand asked for approval to send an email to residents of YHM encouraging everyone to attend the monthly meetings at the Clean & Safe Ambassador Community Center. This was approved by the board (6 Yes, 0 No).

DISCUSSION OF Review and Update of Covenants

The board discussed the need to hire a professional consultant to review and update the YHM POA Inc. covenants. Cost is a concern and so is participation from homeowners. The board would like to get 2 quotes to undertake this project before moving forward.
